**STIPULATION AND PRETRIAL ORDER NO. 5549**


AND NOW, this 15<sup>th</sup> day of August, 2005, it is hereby STIPULATED, ORDERED, ADJUDGED and DECREED, pursuant to Federal Rules of Civil Procedure 41(a)(1)(ii), that plaintiff SHELLY WINSLOW hereby dismisses with prejudice this action as to all defendants, Wyeth, Wyeth Pharmaceuticals, Inc., and Wyeth-Ayerst International, Inc., (collectively herein "Wyeth"), with each party to bear its own costs and counsel fees. This dismissal shall be with prejudice. Notwithstanding the foregoing, this dismissal shall be subject to the terms and conditions in the Nationwide Class Action Settlement Agreement and as agreed to in the Revoke Opt-Out Form executed by the plaintiff SHELLY WINSLOW on March 1, 2004, and agreed to by Wyeth on April 7, 2004.

This Stipulation is filed on behalf of plaintiff SHELLY WINSLOW and defendants, Wyeth, Wyeth Pharmaceuticals, Inc., and Wyeth-Ayerst International, Inc., who have appeared in the above-captioned matter.




