AND NOW, this 15<sup>th</sup> day of August, 2005, it is hereby STIPULATED, ORDERED, ADJUDGED and DECREED, pursuant to Federal Rules of Civil Procedure 41(a)(1)(ii), that plaintiff Delana Hay hereby dismisses this action as to all defendants in the above-captioned matter, Wyeth<sup>1</sup>, with each party to bear their own costs and counsel fees. Notwithstanding the foregoing, this Stipulation and Order shall be subject to Nationwide Class Action Settlement Agreement.


This Stipulation is filed on behalf of plaintiff Delana Hay and defendant Wyeth, who have appeared in the above-captioned matter.

On March 22, 2002, Wyeth-Ayerst Laboratories Division ("WALD"), an unincorporated division of Wyeth, changed its name to Wyeth Pharmaceuticals.
