STIPULATION AND PRETRIAL ORDER NO. 5559


AND NOW, this 15th day of August, 2005, it is hereby STIPULATED, ORDERED, ADJUDGED and DECREED, pursuant to Federal Rules of Civil Procedure 41(a)(1)(ii), that plaintiff ANITA MURRAY hereby dismisses with prejudice this action as to all defendants, Wyeth, Wyeth Pharmaceuticals, Inc., Wyeth Pharmaceuticals, Inc., a Delaware Corporation, Wyeth, Inc., Wyeth, Inc., a Delaware Corporation, Wyeth-Ayerst International, Inc., and Wyeth-Ayerst International, Inc. a New York Corporation (collectively herein "Wyeth"), with each party to bear its own costs and counsel fees. This dismissal shall be with prejudice. Notwithstanding the foregoing, this dismissal shall be subject to the terms and conditions in the Nationwide Class Action Settlement Agreement and as agreed to in the Revoke Opt-Out Form executed by the plaintiff ANITA MURRAY on February 28, 2004, and agreed to by Wyeth on April 7, 2004.

This Stipulation is filed on behalf of plaintiff ANITA MURRAY and defendant Wyeth, Wyeth, Pharmaceuticals, Inc., Wyeth, Inc., and Wyeth-Ayerst International, Inc. who have appeared in the above-captioned matter.


