

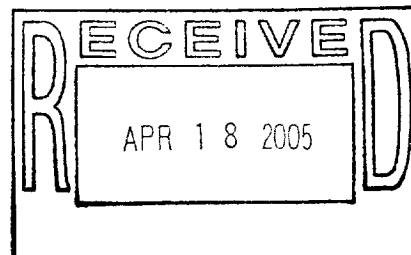
STIPULATION AND PRETRIAL ORDER NO. 5047


