**STIPULATION TO DISCONTINUE SHOW CAUSE PROCEEDING  
BETWEEN CLAIMANT MARIETTE FEATHERSTONE AND THE AHP  
SETTLEMENT TRUST AND TO VACATE PRETRIAL ORDER NO. 3380 IN PART**

Mariette Featherstone ("Claimant") and the AHP Settlement Trust (the "Trust")  
(collectively the "Parties") hereby stipulate and agree that the Trust inadvertently failed to  
provide the Auditing Cardiologist with the echo of attestation in the claim. Accordingly, the  
Parties agree that the Post-Audit Determination should be rescinded.

It is further agreed that the Show Cause proceeding initiated herein by the Trust against  
Claimant should be discontinued and that Pretrial Order No. 3380, issued by the Court March 26,  
2004, as it pertains to Claimant Mariette Featherstone, should be vacated without prejudice, to

allow a further audit of her claim, and, in the event of the claim being denied, the contest procedures as set forth by the Court, to thereupon proceed without delay.




