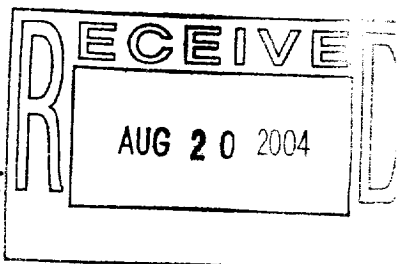

Agreement.


This stipulation complies with Federal Rule of Civil Procedure Rule 41(a)(1)(ii). All
