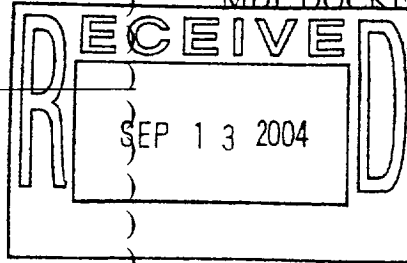


PLAINTIFFS' STIPULATION OF DISMISSAL


