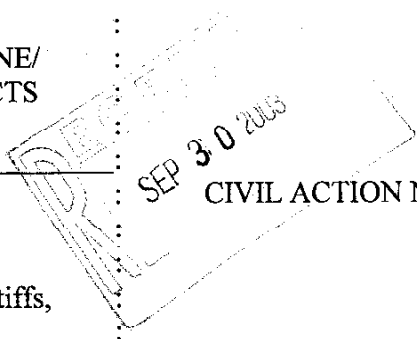


**STIPULATION TO DISCONTINUE SHOW CAUSE
PROCEEDING BETWEEN CLAIMANT GERMAINE DAVIS AND THE AHP
SETTLEMENT TRUST AND TO VACATE PRETRIAL ORDER NO. 2910 IN PART**
