

**STIPULATION TO DISCONTINUE SHOW CAUSE PROCEEDING
BETWEEN CLAIMANT DONNA MCCARTY AND THE AHP
SETTLEMENT TRUST AND TO VACATE PRETRIAL ORDER NO. 3046 IN PART**

Donna McCarty (“Claimant”) and the AHP Settlement Trust (the “Trust”) (collectively the “Parties”), hereby stipulate and agree that the Show Cause proceeding initiated herein by the Trust against Claimant should be discontinued and that Pretrial Order No. 3046, issued by the Court October 1, 2003, as it pertains to Claimant Donna McCarty, should be vacated. Claimant Donna McCarty’s pending Show Cause Proceeding, ordered by the Court in Pretrial Order 2877, issued May 30, 2003, shall not be effected by this Stipulation.
