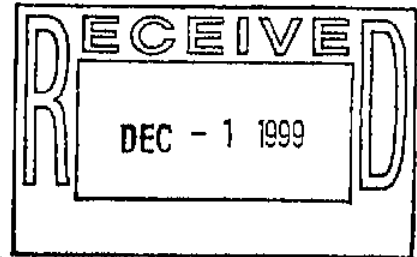

STIPULATION AND PRETRIAL ORDER NO. 1027

AND NOW, this 3rd day of Jan, 2000, 1999, it is hereby STIPULATED, ORDERED,

ADJUDGED, AND DECREED pursuant to Federal Rule of Civil Procedure Rule 41 (a)(1)(ii),
that the claims in the Complaint in the above-captioned matter are hereby dismissed without
prejudice as to all named defendants with each party to bear its own costs and counsel fees.

personal injuries relating to diet drug litigation, plaintiff shall file said case in federal court.
