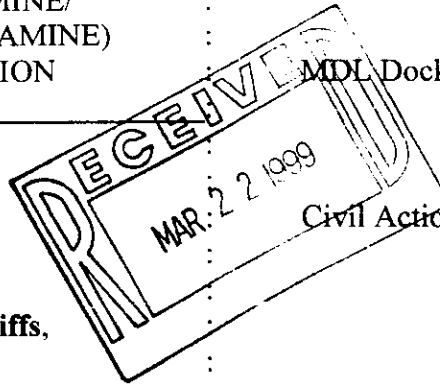


STIPULATION AND PRETRIAL ORDER NO. 525

AND NOW THIS 15<sup>th</sup> day of March, 1999, it is hereby STIPULATED,  
ORDERED, ADJUDGED, and DECREED pursuant to Federal Rule of Civil Procedure Rule  
41(a)(1)(ii), that the claims in the Complaint in the above-captioned matter are hereby dismissed  
without prejudice as to all named defendants with each party to bear its own costs and counsel  
fees.

Further, the Plaintiffs agree that should they decide to institute a case in the future for  
personal injuries relating to diet drug litigation, Plaintiffs shall file said case in federal court, in  
the event federal court jurisdiction can be properly pleaded.


This Stipulation is filed on behalf of all Defendants who has appeared in the above-






