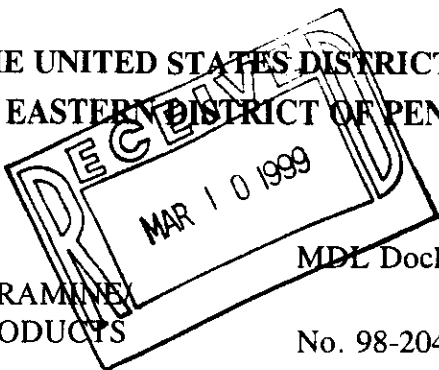


**STIPULATED DISMISSAL OF ACTION**


