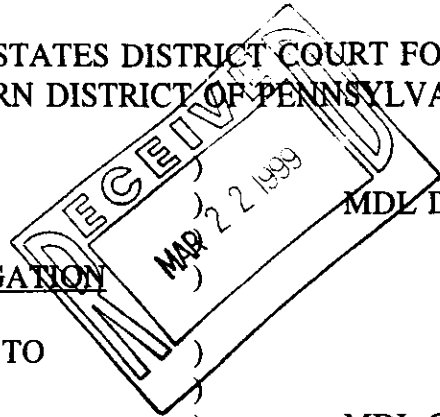

STIPULATION OF DISMISSAL AND PROPOSED PRETRIAL ORDER

Pursuant to Rule 41(a)(1)(ii) of the Federal Rules of Civil Procedure, it is hereby stipulated between all parties hereto, by and through their undersigned attorneys, that plaintiff's complaint is dismissed without prejudice as to Defendants SmithKline Beecham Corporation ("SKB"); Medeva Pharmaceuticals, Inc. ("Medeva"); Ion Laboratories, Inc. ("Ion"); Abana Pharmaceuticals, Inc., and/or Jones Pharma, Inc., formerly known as Jones Medical Industries, Inc., successor to Abana Pharmaceuticals, Inc. ("Abana"); and Gate Pharmaceuticals, a division

of Teva Pharmaceuticals, U.S.A., Inc. ("Gate"). This dismissal is based on plaintiff's inability to establish that she ingested a SKB, Medeva, Ion, Abana, or Gate phentermine product. Each party is to bear their own fees and costs.


All parties to this action that have entered an appearance and that remain in this action have executed this dismissal through the undersigned counsel of record. This stipulation does not affect the status of any other party.






