STIPULATION AND PRETRIAL ORDER No: 560

AND NOW THIS 7th day of April, 1999, it is hereby STIPULATED,
ORDERED, ADJUDGED, and DECREED pursuant to Federal Rule of Civil Procedure Rule
41(a)(1)(ii), that the claims in the Complaint in the above-captioned matter are hereby dismissed
without prejudice as to all named defendants with each party to bear its own costs and counsel
fees, and without the need for plaintiff(s) to provide class notice to the putative class alleged in the
Complaint, as all class allegations have been dismissed with prejudice under Pretrial Order 450.

Further, the Plaintiff agrees that should he decide to institute a case in the future for personal injuries relating to diet drug litigation, Plaintiff shall file said case in federal court, in the event federal court jurisdiction can be properly pleaded.




